

## COOKIES POLICY

Pursuant to the current legislation on the protection of personal data (EU Regulation 2016/679), we wish to inform you that the processing of your data will be carried out with correctness and transparency, for lawful purposes and protecting your privacy and your rights.

As for cookies, here is all the specific information.

### What is a cookie?

A cookie is a small text file that is stored on your computer by the site you are visiting or by different web servers (so-called third parties). It stores data that is sent from your browser to the website when you visit that site again or while you navigate from one page to another on the site.

### How are cookies classified?

Cookies are classified into:

- *session cookies*: they have a limited duration for visiting the website and are therefore removed when the user closes the browser;
- *permanent cookies*: they have a duration that varies according to the cookie used and remain in the device used for a specific time.

### Which cookies are used on this site?

#### ✓ **Technical cookies**

*Technical cookies are used to browse or provide a service requested by the user. They are not used for other purposes and are normally installed directly by the website owner.*

Our website cannot work properly without these cookies:

cookieLawInfo-checkbox-necessary:

1 year

Determines if the user has accepted the cookie consent box.

cookieLawInfo-checkbox-non-necessary:

1 year

Determines if the user has accepted the cookie consent box.

\_icl\_visitor\_lang\_js:

1 day

Saves the user's preferred language on the internet site.

wpml\_browser\_redirect\_test:

duration session

Saves the user's preferred language on the internet site.

#### ✓ **Statistical cookies**

*Statistical cookies (also called analytical cookies) help us understand how visitors interact with the site by collecting and transmitting information anonymously:*

\_ga:

2 years

Registers a unique ID used to generate statistical data on how the visitor uses the internet site.

\_gat:

1 day

Used by Google Analytics to limit the frequency of requests

\_gid:

1 day

Registers a unique ID used to generate statistical data on how the visitor uses the internet site.

✓ **Marketing and profiling cookies**

Marketing cookies are used to track website visitors in order to view ads which are relevant and engaging for the individual user:

No marketing or profiling pixels are present

For marketing and profiling cookies, the interested party's consent is required which is expressed through the banner that appears upon first access to the site.

**How can you avoid the storage of cookies on your computer?**

It is possible to set preferences for cookies on each browser (Internet Explorer, Google Chrome, Mozilla Firefox or Safari).

There are several ways to manage cookies, for example: enable or disable cookies completely; delete **specific cookies that have already been stored in the browser**; block the storage of cookies on your computer by specific websites; or block third-party cookies (when, while browsing a website, cookies are stored on your computer by another website).
